During the 24-hour period till 9am on Monday, the state also logged 11,034 recoveries and 33 deaths, resulting in a drop in the total of active cases by 1,682, to 1,58,623. This was the first instance of a drop in the third wave. The last drop in the total of active cases was registered on December 27 last

Although the infection count was considerably less than that of Sumday (total 14,538 in Bengal and 3,838 in Calcutta), theseta legoged only 3,5,515 tests on Monday. The



Calcutta: The Bengal govern-ment has decided to pull up of-ficials in the transport depart-ment after showcausing them for the plying of overloaded trucks and other goods vehi-

trucks and other goods vehicles, a practice that has been strictly banned.

Transport minister Fir had Hakim said on Monday that complaints of overloading of trucks were mostly pouring in from parts of Birbhum, Murshidabad and the two districts of Burdwan, where most said and stone mine quarries are located.


