Hamas chief Yahya Sinwar was killed by IDF soldiers and his death paves way for getting hostages out: Israeli FM

JERUSALEM

IN a message to dozens of foreign ministers around the world. Foreign Minister Israel Katz confirms that Hamas leader Yahva Sinwar was killed, becoming the first Israeli official to do so on the record, The *Times of Israel* reported.


"The mass murderer Yahya Sinwar, who is responsible for the massacre and atrocities of October 7, was killed today by IDF soldiers," said Katz, according to his office. "This is a great military and moral achievement for Israel and a victory for the entire free world against the evil axis of radical Islam led by Iran," he

Katz said the killing "creates a possibility" for getting the hostages out immediately and for creating a Gaza free of Hamas and Iranian control. "Israel needs your support and assistance now more than ever to advance these important goals together," Katz finishes.

The Republican speaker of the US House of Representatives on Thursday applauded the killing of Hamas leader Yahya Sinwar, saying his death had brought "relief" to the people of Israel.

"Sinwar's life was the embodiment of evil and marked PTI in a statement. "His death

brings hope for all those who seek to live in freedom, and relief to Israelis he has sought to oppress."

Israel accuses Sinwar of masterminding the attack, the deadliest in Israeli history, and has been hunting him down since the start of the Gaza war. He became the Iran-backed Palestinian militant group's new leader after the killing of its former political chief Ismail Haniyeh in July. Hamas and Iran blame Israel for Haniyeh's killing in an attack in Tehran.

Sinwar comes weeks after it assassinated Hezbollah chief Hassan Nasrallah in a massive strike in Lebanon, where its military has escalated a war since late September. A slew of other Iran-backed militant commanders have also been killed in recent months.

Israel said earlier this year that it had killed Mohammed Deif, Hamas's military chief, in a strike, though the Palestinian group has not confirmed it. Deif stood accused of working with Sinwar to plan the October 7 attack.



Gaza war, Sinwar's death, if confirmed, would deal a seismic blow to the organisation.

In a brief statement, the military said that during "operations in the Gaza Strip, three terrorists were eliminated". Hamas has not confirmed his death. An Israeli strike on a school sheltering displaced people in northern Gaza on Thursday killed at least 15 people, including five children, actary aid if its ally does not do With Hamas massively weak-cording to Gaza's Health more to address the humanitar-

The Israeli military said the strike targeted dozens of Hamas and Islamic Jihad militants who had gathered at the school. The strike hit the Abu Hussein school in Jabaliya, an urban refugee camp in northern Gaza where Israel has been waging a major air and ground operation for more than a week.

Fares Abu Hamza, head of the ministry's emergency unit in northern Gaza, confirmed the toll and said dozens of people were wounded. He said the nearby Kamal Adwan Hospital was struggling to treat the casualties. "Many women and children are in critical condition,' he said.

The military said it targeted a command centre run by both militant groups inside the school. It provided a list of dozens of names of people it identified as militants, who were present when the strike was called in.

The Gaza Strip is still at risk of famine more than a year into the Israel-Hamas war, even as the number of people facing the most extreme level of hunger has declined in recent months, the international authority on hunger crises said on Thursday. The findings come after the United States warned Israel that it might cut off miliian crisis in Gaza. AP/AFP
