# Cong, BJP spar over Karnataka govt hiring foreign firm to govern finances

BJP state president Vijayendra terms move to hire consultation firm at ₹9.5 cr outrageous

THE Congress government's decision to hire Boston Consulting Group (BCG) for a whopping ₹9.5 crore for six months to oversee the state's finances has triggered a political controversy.

With Opposition BJP taking strong exception to the decision, the ruling Congress hit back stating that even Prime Minister Narendra Modi-led NDA government had hired BCG to prepare its 'Vision Document 2047'.

BJP state president BY Vijay-

endra on Thursday termed the state government's move outrageous. "Outrageous decision by the Siddaramaiah government to hire a foreign consultant to oversee our state's finances. This is akin to handing over the reins to the

East India Company," he posted on 'X'. Reacting, Industries Minister MB Patil said BCG is a prestigious firm with a global presence. "The BJP should first question why PM Modi appointed BCG to prepare Vision Document 2047. Baseless alle-

gations like this don't deserve

any attention," he posted on 'X'. Patil said BCG has been hired in a transparent manner by inviting tenders. He added Vijayendra should first do his

homework properly before making such statements. Replying to the allegation that Siddaramaiah government's financial status is in a bad shape

owing to the implementation of five guarantee schemes and this led to hiring BCG to help boost its revenues, Patil sought to know if the Modi government too faced a similar situation and

Health and Family Welfare Minister Dinesh Gundurao also criticised the BJP for making it an issue.

Opposition leader R Ashoka posted on 'X': "What is the need for hiring Boston Consulting Group when a self-proclaimed economist like Siddaramaiah is the Chief Minister of the state? Not sure whether it will boost the revenues of the state. But it will definitely boost the revenues of the private consultancy firm at the cost of Karnataka's taxpayers." Professionals' Congress chairman Praveen criticised the government for hiring the BCG.

## 'Work load too heavy for elderly people, women'

THE State Planning Commission, following a rapid assessment of the scheme, said the work load for the wage paid could be too heavy, especially for women and senior citizens. The commission also said that there was scope to explore the possibility of offering other kinds of unskilled work to beneficiaries such as construction and maintenance of community assets. It also said the upper age limit of 60 could also be extended. Official sources said there were instances of caste based allocation of work in some areas. The scheme is now being carried out in 87 town panchayats with a daily wage of ₹300. In these town panchayats, 1.48 lakh job cards have been issued so far. The beneficiaries are employed for deepening of ponds, strengthening bunds, cleaning inlets and outlets, and tree plantation. The directorate, which got initial allocation of ₹27 crore, has now received an additional ₹10.37

Beneficiaries are also allowed to continue work even after the completion of minimum 100 days. But even here, the scheme faces challenges, sources said. For instance, the wages are paid after a weekly 'measurement' of the work. This created friction between the beneficiaries and the engineers.

"Masons, in town panchayats, get around ₹600 a day. Sometimes, when the work is measured and found unsatisfactory, they are paid only ₹150 to ₹250 which the beneficiaries don't accept," said an official. The scheme was launched to guarantee basic minimum wages in urban local bodies along the lines of the Mahatma Gandhi National Rural Employment Guarantee Act.

### 135 victims still hospitalised

CONTINUED RFOM PAGE 1: The death toll in the Kallakurichi hooch tragedy touched 50 on Friday. The victims include five women and one transperson. Sixteen patients in Salem died failing treatment, four died in Villupuram and three died in JIPMER. Besides, 27 people who received treatment at Kallakurichi GMCH died, while 135 still hospitalised. At least 15 people from areas like Madhavacheri, Ammapettai and Kacharapalayam have been admitted to hospitals and two had died. "More people are affected there but they are trying to escape medical teams to avoid being hospitalised," said K Kaveri (35), a school teacher. Some locals said that there could have been few cases in nearby villages where people died without coming to hospitals. At least 25 people from Seshasamudram and Sankarapuram areas located near Kalvarayan hills were hospitalised, and three of the victims are dead. (With inputs from Krithika Srinivasan)


