

# Sugam App launched for online registration of property

The Chhattisgarh government is implementing user-friendly initiatives that prioritize the interests of the public. Online registration of property through Sugam App is one such initiative.

Since its launch on October 21, the app has quickly gained popularity, facilitating over 1,200 property registrations across the state and marking a significant shift towards online registration.

The app seeks to make the registry process more transparent and user-friendly.

Finance Minister O.P. Choudhary said in a statement: "The government is committed towards more and more



technological applications and procedural improvements in the registry work for citizen empowerment.

"Sugam App is an important step towards preventing property related fraud," he said.

A government official said that at times a property is sold to different people and in some cases registries are done for properties

that do not actually exist. There are also instances where land designated for roads, pathways or gardens is sold fraudulently.

In some cases more land is sold than what is physically available. These incidents contribute to disputes and an increase in court cases.

In the Sugam App, during registration, the party will physically go to

the place where the registration is being done with his mobile.

At that place, photos are taken from three different angles as directed in the app -- front, right and left of the property. That photo will be transferred to the registrar's module for registering the latitude and longitude of the place along with the photo.

In this way, the app coordinates the actual geographical position of the property to be permanently recorded in the registry paper, so that the party can go to that place anytime and identify the property.

Through the app, incidents of causing revenue loss to the government will be curbed, the official said.

# PM to virtually open Super Specialty Hospital

hospital. Collector Awanish Sharan took stock of the preparations on Friday. A huge 10-floor hospital has been built in Koni at a cost of about Rs 200 crore. It will have six super specialities.

Initially, preparations for OPD of four departments have been made -- urology, nephrology, neurosurgery and general medicine.

# 46 nominations filed for Raipur South constituency

The Election Commission in Chhattisgarh has received a total of 46 nominations for the Raipur City South Assembly by-election. The deadline for filing nominations was Friday.

They will be scrutinised on October 28. Candidates can withdraw their nominations until October 30.

Voting will be held on November 13 in 253 polling centres. Votes will be counted on November 23.

There are a total of 2,70,936 people eligible to exercise their franchise, of which 1,33,713 are men, 1,37,171 are women and 52 belong to the third gender.

The by-election was necessitated as BJP MLA Brijmohan Agrawal vacated the seat after being elected as MP from Raipur.

# Authorities move to curb sale of substandard sweets

Ahead of Diwali festival, authorities in Chhattisgarh are taking steps to prevent the sale of low-quality sweets and fake khawa, an official communiqué said on Friday.

Consumption of fake or adulterated khawa can cause a variety of health issues like



gastrointestinal problems, food poisoning, bacterial infection, liver and kidney damage, and worsening pre-existing issues.

The Food and Drug Administration is conducting a thorough inspection of the sweet shops and collecting samples for testing.

The administration personnel in Surguja have sent the samples to the State Food Testing Laboratory in

Raipur.

If the samples are found not up to standards, then action will be taken under the Food Safety and Standards Act 2006 Rules and Regulations 2011.

Along with this, they are imposing fines on the shops failing to maintain cleanliness.

A campaign is also underway to raise awareness about the importance of food safety standards.
