## SC rejects Ghosh's petition

New Delhi: The Supreme Court on Friday dismissed a plea filed by former RG Kar principal Sandip Ghosh challenging a Calcutta High Court order rejecting his petition to be added as a party to a case of alleged financial irregularities at the hospital.

The bench of Chief Justice D.Y. Chandrachud and Justices J.B. Pardiwala and Manoi Misra said as an accused, Ghosh has no locus standi to be impleaded in the matter.

"You were the principal of the college when the incident took place. As an accused you have no locus (standi) to intervene in the PIL, where Calcutta High Court is monitoring the investigation," the bench said.

The high court had on August 23 transferred the probe into the alleged financial irregularities from a special investigation team (SIT) set up by the state government to the CBI.

Senior advocate Meenakshi Arora, appearing for Ghosh, said he was not objecting to the CBI inquiry but was aggrieved at certain adverse remarks made by the high court.

Solicitor-general Tushar Mehta, appearing for the CBI, said an accused could not direct the manner in which the probe should proceed. "Let us not stultify the in-

vestigation. We are also asking the CBI to file status reports before us," the bench said while dismissing the plea.

## Accused in judicial custody

Sealdah: Sanjay Roy, the civic volunteer arrested for the RG Kar rape and murder, was sent to judicial custody for 14 days by a Sealdah court on Friday.

Roy, who was arrested by Kolkata Police on August 10 and later handed over to the CBI, attended the hearing virtually. Sources said he was not taken to the court because of apprehensions about his security.

Roy's lawyer moved a bail plea and submitted that his client was innocent. "He is not involved in the crime and has been framed.... He should be granted bail," Roy's lawyer

The CBI lawyer turned up at least 40 minutes later.

"We are having a court hearing here where the accused is present virtually. Where is the CBI lawyer?" the judge asked a CBI officer. "Ask the lawyer to come within 10 minutes.'

The officer stepped out of the court to call the lawyer. Minutes later the officer told the judge that the lawyer would arrive within a few min-

The CBI lawyer opposed Roy's bail plea. After hearing both sides, the court sent Roy to 14 days' judicial remand.

# **Reclaim the** Night call on hearing eve

Calcutta: On the eve of the Supreme Court hearing on the RG Kar rape and murder, women's groups have called for Reclaim the Night protests from 11pm on Sunday.

The intervening night between Sunday and Monday morning will also mark one month since the 31-year-old postgraduate trainee of RG Kar was raped and killed in the college.

Several other rallies and protest marches are also planned for Sunday.

The call to Reclaim the Night on Sunday came from 29-year-old social science researcher Rimjhim Sinha, who was also among the first to give the call to reclaim the night on the eve of Independence Day. The sea of people that descended on the streets on the night of August 14 transformed the RG Kar protest into an unparalleled people's movement.

On Friday, Sinha said: "We are giving this call as we not only want justice for the young doctor who was brutally raped and murdered at her workplace but the safety of women in all places. Sadly, with every government that we have had women's safety has been largely ignored."

The night vigil called by Sinha and several other women will start at 11pm.




