Chingrighata traffic trial from today

Calcutta: Beginning Saturday, a portion of the Chingrighata intersection on EM Bypass will be blocked for a traffic trial. which will let police figure out how vehicle flow will be hit if Metro authorities construct a pillar at the crossing.

"The trial will be held for four days. We want motorists to get used to it in the first two days when vehicular load is expected to be comparatively low," said Surya Pratap Yaday, deputy police commissioner responsible for managing the city's traffic.

"Depending on the outcome, we will decide when Metro authorities can start constructing the pillar."

"Pillar number 318" is key to holding the viaduct of the New Garia-Airport Metro that takes a curve from Chingrighata towards Salt Lake from EM Bypass. The construction of the pillar has been stalled for the last few years with the police and the CMDA which maintains EM Bypass - saying traffic disruption on the busy corridor may


