- 2. That after availing the aforesaid loan, you the above-named addressees being the Borrower/Co-Borrower/Mortgagors committed default in repayment of the loan amount and in view of the continuous default of more than the time period stipulated under the relevant applicable guidelines/circulars for asset classification issued by Reserve Bank of India (RBI), your loan account(s) was classified as Non-Performing Asset (NPA) on 14.02.2022 in accordance with the concerned guidelines issued by Reserve Bank of India (RBI).
- 3. That thereafter, a demand notice dated 18.04.2022 U/S 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (SARFAESI Act) was duly served on you, the addressees but you failed to make the payment of demanded amount i.e. Rs. 5,73,18,083.50/- (Rupees Five Crores Seventy-Three Lakhs Eighteen Thousand Eighty-Three and Paise Fifty Only) (exclusive of TDS Calculation) by way of Outstanding Principal, arrears (including accrued late charges) and interest due as on 08.04.2022 within 60 days of the receipt of the said notice and as such the Secured Creditor has taken physical possession of the Secured Assets in compliance of the provisions of the SARFAESI Act, 2002 and rules framed thereunder on 28.07.2022.
- 4. That thereafter, the secured creditor decided that the secured assets may be put to sale in accordance with Rule 8(5) by holding public auction through E-auction mode. It is stated that the Authorized Officer has obtained valuation of the secured assets from an approved valuer and in consultation of the Secured Creditor the Authorized Officer had fixed the reserve price of the secured assets basis the valuation received and conducted E-Auction on multiple occasions however, the said E-Auctions failed due to lack of bids.
