Stabbed girl undergoes surgery for head injury

Calcutta: The 11-year-old girl who was stabbed multiple times by a Class XI student in Belgharia on Wednesday underwent surgery on the head at a private hospital on Thursday, an official of the hospital said.

According to the official, the girl suffered injuries on her head, hands, shoulders and neck.

"She was stabbed multiple times. She underwent surgery on the head early on Thursday," said the official of the hospital off EM Bypass.

According to the official, the girl remains in a critical state and is admitted to the paediatric intensive care unit of the hospital.

Although critical, the girl's vitals are stable and she is responding to the treatment, the official added.

A senior officer of the Barrackpore Commissionerate on Thursday said the boy who had attacked the girl and her mother while they were walking home from school was also being treated at a hospital.

"Our officers have spoken to the boy. He had earlier professed his love for the girl but she had turned him down. On Wednesday, he had done the same and was turned down. The boy then hurled abuses at the girl after which she slapped him. He told us that he started stabbing her with a knife in a fit of rage," said the

According to the officer, they have started a case and have booked the teenager under attempt to murder charges.

"We will question him again once he is discharged from the hospital," said the officer.

The girl's mother on Thursday said that she wanted the highest form of punishment for the teenager.

"My daughter is in a critical state and underwent surgery. Her hands, shoulders and neck are badly injured. I still cannot believe that the boy could do something like this. I want the highest form of punishment for him," the mother said.

On Wednesday afternoon, the boy waited for the girl and mother inside a tunnel below the Nibedita Setu.

As they were walking by the boy confronted them and stabbed the girl after she slapped him.

The boy also injured the girl's mother after she tried to protect her.

Residents managed to take the knife away from the boy and thrashed him before a police team rescued him.

SNEHAL SENGUPTA Barasat: Eighteen persons who took part in a night vigil

to demand justice for the RG Kar victim were arrested for allegedly blocking NH12 at Barasat in North 24-Parganas for more than three hours early on Thursday.

All of them were produced in the Barasat court on Thursday afternoon. They were granted bail.

Anirban Das, a resident of Barasat who was part of the vigil, alleged that the police charged at them without warning and said that many, including women, were beaten up.

"The cops charged at us without any provocation and thrashed several protesters." Das said.

"The police kept on trying to break the human chain we had formed claiming that we had no right to block such an important road," said Das.

"A senior officer shouting instructions at us was asked by

many in the crowd to speak in Bengali. This seemed to enrage him. They have even beaten up a child who was trying to protect his mother," Das alleged.

NH12 connects Barasat with Dalkhola in North Dinajpur. It also serves as the main connector between north Bengal and Calcutta. The protesters had blocked

both the city-bound and the Krishnagar-bound flank of the highway, the police said. A senior officer said multiple night vigils were scheduled

at Barasat, including one at Dak

Bungalow More intersection and the one at Colony More. According to the officer,

several men and women who were part of the vigil at the Dak Bungalow More intersection walked towards Colony More and squatted on the highway.

The superintendent of police of Barasat, Pratiksha Jharkhariya, said after the group blocked the highway, a police team from Dak Bungalow More intersection went to the Colony More intersection.

"We requested those taking part in the vigil to free at least one lane of the citybound flank of the highway but they did not listen," said Jharkhariya.

Around 3.15am, a large police team reached the spot and the protesters were asked once again to move back, the officer

A group then attacked the police team and tried to snatch their batons, said the officer.

"We pushed the crowd back and arrested those who had attacked the police," the officer added.

HC scanner on posts naming victim

Calcutta: The high court on Thursday reacted sharply to social media posts revealing the identity of the junior doctor who was raped and murdered at RG Kar Medical College and Hospital.

A division bench headed by Chief Justice T.S. Sivagnanam sought a report from the CBI joint director by the next hearing on September 18.

The law prohibits the naming or identification of a person who has been raped.

"This court had earlier issued an order asking persons allegedly posting various items showing the picture of the victim to withdraw their posts immediately. The court had also issued a ban on any social media posts having the picture of the victim. It is a

matter of concern that some people are not obeying the order," the chief justice said.

The bench announced that the court would take strong action against such offenders. "Since the CBI is handling the case, the court is directing the joint director of the CBI to file a report on the issue," said the bench, also including Justice Hiranmay Bhattacharyya.

The bench was hearing a plea alleging that some social media users were still uploading posts containing pictures of the rape and murder victim.

Appearing for the CBI, additional solicitor-general Ashok Chakrabarty said: "The CBI has no particular wing to handle cybercrime-related issues. The state government has a department to handle cybercrime-related issues. So the job should be handed over to the state."

At this, the chief justice said: "In that case, the CBI would take the assistance of the state cyber crime department. The state cyber crime department is directed to cooperate if the CBI wants it from them."

According to Section 72 of the Bharatiya Nyaya Sanhita, anyone who prints or publishes the name or any other information that can reveal the identity of a person who has been subjected to "rape or sexual assault could be punished with imprisonment for up to two years and shall also be liable to fine".

The Supreme Court, which took up the RG Kar case suo motu, has in multiple orders earlier barred the sharing of information that can disclose the identity of a rape victim.

While hearing this case on August 20, the top court directed the Centre to remove all references to the name, photos and clips of the RG Kar victim from social media and electronic media platforms.

On Thursday, a lawyer present in the high court said: "Most of these social media posts are fake. In some of the posts, abusive language is being used. There should be a special

cell to find out the culprits." The chief justice said: "The investigating agency will take all possible steps in this regard. The court will not allow such things anymore."

Earlier, the same issue was raised before the same court where lawyers pointed to the Supreme Court bar on revealing theidentity of a rape victim.

the division bench directed the immediate withdrawal of such posts and issued a bar on such posts.
