## Global PC shipments rise 4.9% in Q1 2025 amid tariff uncertainty

**TERSONAL Computer (PC)** shipments grew by 4.9% year-on-year during the first quarter of 2025, with global volumes reaching 63.2 million units, according to the International Data Corporation (IDC). However, the outlook for the rest of the year remains uncertain as the PC industry faces both tailwinds and headwinds, complicating demand forecasting and planning, IDC noted in its report. "The market is clearly show-

ing some level of pull-in during the first quarter of this

year, as both vendors and end-users brace for the impact of US tariffs. In a first quarter still relatively untouched by tariffs, the entire ecosystem attempted to accelerate the pace of deliveries to avoid the first round of US tariffs and expected volatility for the remainder of the year," said Jean Philippe Bouchard, Research Vice President with IDC's Worldwide Mobile Device Trackers.

Bouchard further men-

tioned that demand remained strong in the first quarter, but the new round of US tariffs announced on 2nd April could have a direct inflationary impact on the PC market, potentially resulting in delayed IT spending for the remainder of the

Several key demand drivers for PCs—such as upgrades ahead of Windows 10's end-of-support deadline and growing interest in on-device AI—remain strong, as reflected in the Q1 shipment figures. However, increasing uncertainty over US trade policy, inflationary pressures, and global economic risks are expected to negatively affect demand in the coming quarters.

"While many are still unpacking the details from the 2nd April tariff announcement, it's safe to say most are re-evaluating what the following months will look like," said Ryan Reith, Group Vice President with IDC's Worldwide Device Trackers.

Reith added that, in the case of hardware products like PCs, IDC continues to believe that most, if not all, cost increases resulting from tariffs will eventually be passed on to consumers.

#### Which brand topped?

Lenovo led the market with 15.2 million units shipped, capturing a 24.1% share and growing 10.8% year-on-year. HP Inc. followed with 12.8 million units (20.2% share), up 6.1%. Dell Technologies remained third with 9.6 million units (15.1% share), showing modest growth of 3%.

Apple recorded the highest growth rate at 14.1%, shipping 5.5 million Macs to secure an 8.7% market share. ASUS rounded out the top five with 4 million units and 11.1% growth.

While major brands gained, smaller vendors in the "Others" category saw a 3.6% decline, highlighting ongoing market consolidation. Strong commercial demand, Windows upgrades, and interest in AIcapable devices supported Q1 growth, but looming tariffs and economic uncertainty may challenge the industry going

# ■ 2G COVERAGE 4G COVERAGE NOW CHECK MOBILE IN YOUR AREA BEFORE BUYING A SIM

OBILE users in India can now check which network technologies. such as 2G, 4G, or 5G—are available in their area before purchasing a SIM card. This follows a new directive from the Telecom Regulatory Au-

thority of India (TRAI), which requires all telecom service providers, including Reliance Jio, Bharti Airtel, and Vodafone Idea, to publish detailed network coverage maps on their websites. This means consumers can

now view which networks are available at their location and assess their signal strengths before choosing an operator. For instance, if one provider offers only 4G in a specific area while another provides 5G, customers can opt for the one with better service. In rural areas too,

where only 2G or 4G may be available, individuals can make informed decisions based on actual network accessibility.

#### How can users check the network?

To check network availability, users can visit the websites of telecom providers and access interactive maps showing realtime signal strength and service coverage. However, public sector operators BSNL and MTNL have yet to release their maps.

"In a significant move to enhance transparency and empower mobile subscribers, Tel-

ecom Service Providers (TSPs) have published mobile network coverage maps on their websites, as per the mandate given by the Telecom Regulatory Authority of India (TRAI)," said

> TRAI in a press note. The maps display voice and broadband network availability across India and include information based on the user's location. They support 2G, 3G, 4G, and 5G technologies, and allow users to search by location or use GPS to view real-time coverage. Consumers can also toggle between different network types to see what is avail-

to their telecom operator. TRAI has clarified that while the maps offer useful guidance, actual signal experience may vary—particularly indoors due to factors such as building structure or nearby infrastructure.

Beyond assisting individual users, the coverage data also supports government planners, businesses, and developers in expanding digital services and infrastructure more effectively across the country.

## Organisations to use small, task-specific Al

models more by 2027

Y 2027, organisations will implement small, taskspecific AI models three times more often than general-purpose large-language models (LLMs), according to Gartner, an American research and advisory firm. It states that firms planning to adopt small, task-specific AI models should consider piloting contextualised models—particularly in areas where business context is crucial or where LLMs have failed to

meet expectations in terms of response quality or speed. Firms should also adopt composite approaches, such as identifying use cases where single-model orchestration is insufficient, and strengthen their data and

skills capabilities. Gartner recommends that organisations prioritise data preparation efforts to collect, curate and organise the data necessary for fine-tuning language models. Simultaneously, they should invest in upskilling personnel across technical and functional teams, including AI and data architects, data scientists, AI and data engineers, risk and compliance teams, procurement teams, and business SMEs, in order to effectively drive these initiatives. "The

variety of tasks in business workflows and the need for greater accuracy are driving the shift towards specialised models fine-tuned on specific functions or domain data," said Sumit Agarwal, VP Analyst at Gartner. "These smaller, task-specific models provide quicker responses and use less computational power, reducing operational and maintenance costs." Agarwal added.

Enterprises can customise LLMs for specific tasks by employing retrieval-

augmented generation (RAG) or fine-tuning techniques to create specialised models, according to Gartner. "As enterprises increasingly

recognise the value of their private data and the insights derived from their specialised processes, they are likely to begin monetising their models and offering access to these resources to a broader audience, including their customers and even competitors," said Agarwal.

Gartner also identifies the top 12 early-stage technology disruptions, including Earth intelligence, intelligent simulation, polyfunctional robots, and algorithm-aligned silicon. In addition, Gartner notes that GenAI-enabled code architecture will enable dynamic, composable applications.


